

The Scheme particulars have been prepared in accordance with Securities and Exchange Board of India (Mutual Funds) Regulations 1996, as amended till date, and filed with Securities and Exchange Board of India (SEBI). The units being offered for public subscription have not been approved or disapproved by SEBI, nor has SEBI certified the accuracy or adequacy of this KIM.

Investment Objective The investment objective of the scheme is to provide long-term capital appreciation from a portfolio investing in units of overseas equity ETFs which are based on companies involved in development of Electric & Autonomous Vehicles and related technology, components and materials. There is no assurance that the investment objective of the Scheme will be realized.

"Related technology, components and materials" implies companies that produce electric, hybrid and autonomous vehicle components which are used in building of the vehicle, including batteries, fuel cells, car components, communication equipment, Electronic Components, software, communication services, semiconductor, electrical and power equipment's, chemicals, raw materials including metal mining and products (for example lithium, cobalt etc.), sensors, mapping, artificial intelligence, Advanced Driver Assistance Systems, ride-share platforms and network-connected services for transportation.

Debt instruments include securitized debt upto 5% of net assets of the scheme. The Scheme will not invest in Units issued by REITs & InvITs.

The scheme intends to invest in one or more of the below mentioned ETFs:

- Global X Autonomous & Electric Vehicles ETF
- Global X China Electric Vehicle and Battery ETF

The Scheme shall invest only from the aforementioned overseas ETFs.

Overseas Investments:

Under normal circumstances the Scheme may invest up to 100% of net assets in Overseas Financial Assets/Foreign Securities.

The scheme intends to invest in overseas equity ETFs which is denominated in foreign currency. Different underlying ETFs may be denominated in different

foreign currency. The Investor of Mirae Asset Global Electric & Autonomous Vehicles ETFs Fund of Fund will hence be exposed to foreign currency movement. The scheme does not intend to hedge this exposure.

*The Scheme may invest in the schemes of Mutual Funds (including ETFs) in accordance with the applicable extant SEBI (Mutual Funds) Regulations as amended from time to time.

The Scheme may invest in repo/reverse repo in corporate bonds. The gross exposure of the scheme to 'corporate bonds repo transactions' shall not be more than 5% of the net assets of the concerned scheme. The Scheme may invest in Structured Obligations / Credit Enhancements not exceeding 5% of the debt portfolio of the scheme and the group exposure in such instruments shall not exceed 5% of the debt portfolio of the scheme.

The Scheme may invest in debt instruments with special features in accordance with limits as defined in Clause 12.2 of SEBI Master Circular dated May 19, 2023.

The scheme shall not engage in short selling. The scheme shall not invest in any unrated debt instruments. The scheme will not engage in securities lending and borrowing. The Scheme shall not invest in derivative instruments. The scheme shall not invest in credit default swaps.

The cumulative gross exposure to units of equity Exchange Traded Funds, money market instruments, debt instruments, repo transactions, units of debt/liquid schemes of domestic Mutual Funds will not exceed 100% of the Net Assets of the Scheme. However, cash or cash equivalents with residual maturity of less than 91 days shall not be treated in gross exposure as per Clause 12.25.3 of SEBI Master Circular May 19, 2023

Debt securities include, but are not limited to, debt securities of the Government of India, State and Local Governments, Government Agencies, Statutory Bodies, Public Sector Undertakings, Public Sector Banks or Private Sector Banks or any other Banks, Financial Institutions, Development Financial Institutions, and Corporate Entities, collateralized debt securities or any other instruments as may be prevailing and permissible under the Regulations from time to time).

The debt securities (including money market instruments) referred to above could be fixed rate or floating rate, listed, unlisted, privately placed, among others, as permitted by regulation.

Pending deployment of funds of a Scheme in securities in terms of investment objectives of the scheme a mutual fund can invest the funds of the Scheme in short term deposits of scheduled commercial banks in terms of clause 12.16 of SEBI Master Circular dated May 19, 2023.

Investment in Overseas Financial Assets/Foreign Securities:

According to Clause 12.19 of SEBI Master Circular dated May 19, 2023, mutual funds can invest in ADRs/GDRs/other specified foreign securities and such investments are subject to an overall limit of US\$ 7 bn. for all mutual funds put together. The Mutual Fund has been allowed an individual limit of US\$ 1 Billion. The overall ceiling for investment in overseas ETFs that invest in securities is US\$

1 billion subject to a maximum of US\$ 300 million per mutual fund.

The Scheme intends to invest upto a maximum of USD 250 million which shall be valid for a period of six months from the date of closure of New Fund Offer. Post the six month period, the Scheme shall invest not exceeding 20% of the average AUM in Overseas securities / Overseas ETFs of the previous three calendar months subject to the maximum limits mentioned above. Clause 12.19 of SEBI Master Circular dated May 19, 2023, these limits would be soft limits for the purpose of reporting by Mutual Funds on a monthly basis to SEBI in the prescribed format.

The dedicated fund manager appointed for making overseas investments by the Mutual Fund will be in accordance with the applicable requirements of SEBI. In line with clause 12.19 of SEBI Master Circular dated May 19, 2023and all applicable regulations/guidelines/directives/notifications, as may be stipulated by SEBI and RBI from time to time, the Scheme will invest in the units of Listed equity Exchange Traded Funds subject to all approvals vide clause 12.19 of SEBI Master Circular dated May 19, 2023and all applicable regulations/guidelines/directives/notifications, as may be stipulated by SEBI and RBI from time to time.

Subject to SEBI (MF) Regulations, the asset allocation pattern indicated above may change from time to time, keeping in view market conditions, market opportunities, applicable regulations and political and economic factors. It must be clearly understood that the percentages can vary substantially depending upon the perception of the Investment Manager; the intention being at all times to seek to protect the interests of the Unit holders. As per clause 2.9 of SEBI Master Circular dated May 19, 2023 and in line with SEBI clarification letter dated June 29, 2022, such changes in the investment pattern will be for short term and for defensive consideration only. In the event of deviations, portfolio rebalancing will be carried out within 30 calendar days in such cases.

In the event of deviation from mandated asset allocation mentioned above due to passive breaches, the rebalancing will be carried out in 30 business days. Where the portfolio is not rebalanced within 30 business days, justification for the same including details of efforts taken to rebalance the portfolio shall be placed before the Investment Committee and reasons for the same shall be recorded in writing. The Investment Committee, if so desires, can extend the timelines up to sixty (60) business days from the date of completion of mandated rebalancing period in accordance with clause 2.9.2 of SEBI Master Circular dated May 19, 2023 . However, at all times the portfolio will adhere to the overall investment objectives of the Scheme.

Suspension of Purchase of Units and Right to limit redemption of Units:

Subject to the approval of the Boards of the AMC and of the Trustee, and subject also to necessary communication of the same to SEBI, the determination of the NAV of the Units of the Scheme, and consequently of the Purchase and/or switching of Units, may be temporarily suspended in certain cases.

SEBI vide its clause 1.12 of SEBI Master Circular dated May 19, 2023 has laid down certain requirements to be observed before imposing restriction on redemptions.

The scheme intends to invest in ETFs which are based on companies involved in development of Electric & Autonomous Vehicles and related technology, components and materials. The Scheme may also invest, at the discretion of the Investment Manager, a certain portion of its corpus in the liquid/money market schemes of Mirae Asset Mutual Fund. Hence scheme specific risk factors of all such underlying schemes will be applicable. All risks associated with such schemes, including performance of their underlying stocks, derivative instruments, stock-lending, offshore investments etc., will therefore be applicable in the case of the Scheme. Investors who intend to invest in the Scheme are required to and deemed to have understood the risk factors of the underlying schemes.

The scheme may invest in the units of ETFs through the exchange on which the ETF is listed, through the Asset Management Company, or through authorized participant, market marker or any other available counter party. The price at which ETF unit is traded/transacted may be different than the NAV/iNAV of the scheme at that instant. In certain scenarios, due to liquidity constraints in the underlying ETFs, the subscription or redemption in the underlying ETF units may be implemented over multiple days. This may result in the deviation from the performance as compared to the underlying schemes.

The scheme may invest in multiple underlying ETFs in various proportions and include more ETFs for investment on an ongoing basis based on the investment objective of the scheme. The scheme may also redeem completely from the ETFs in which investments were made. Such changes will affect the performance of the scheme. Also, in case the ETF in which scheme has made investment gets delisted/decommissioned, the scheme may also redeem its investment from such scheme or may take any other steps for the benefit of the investors





TERMS AND CONDITIONS

- 1.
