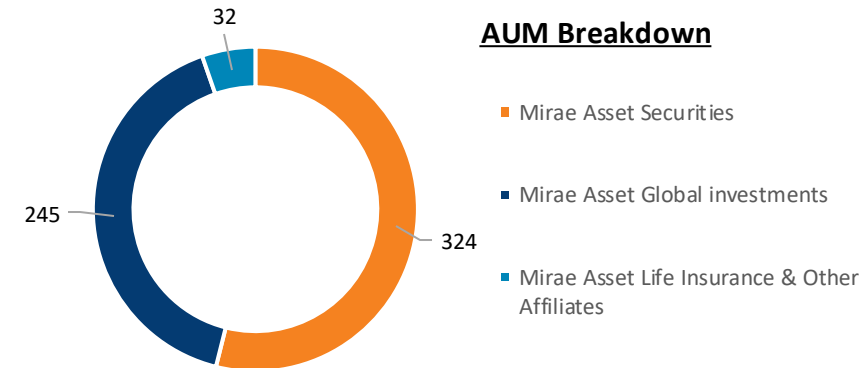

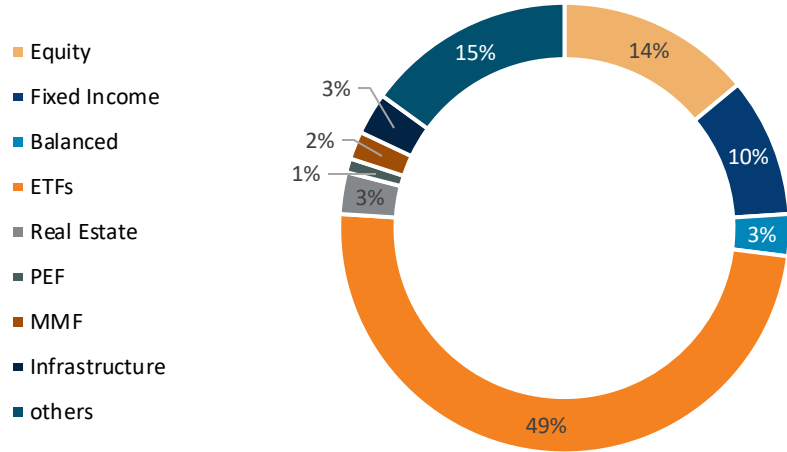


Overview of Assets Under Management globally (MAGI*)

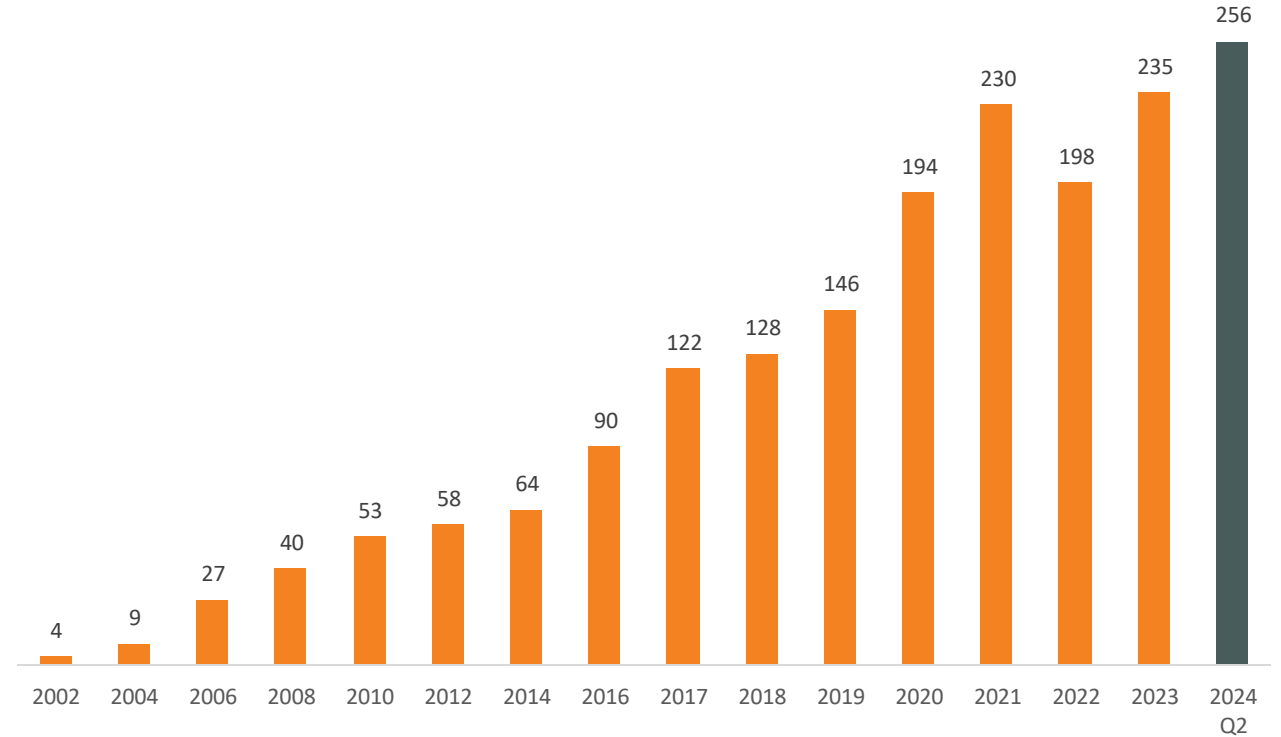
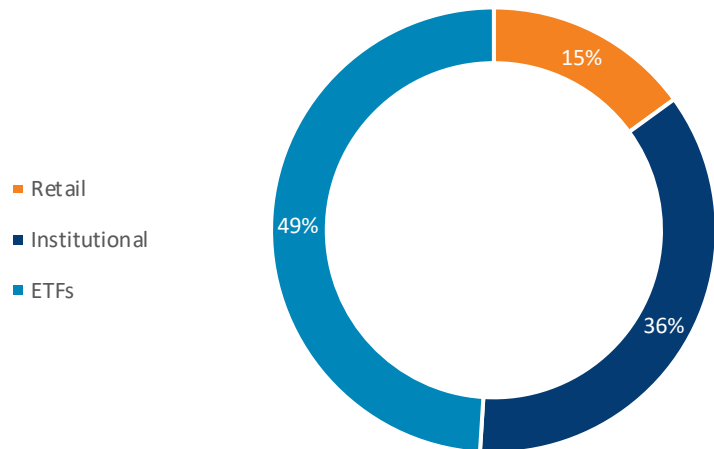

AUM Breakdown



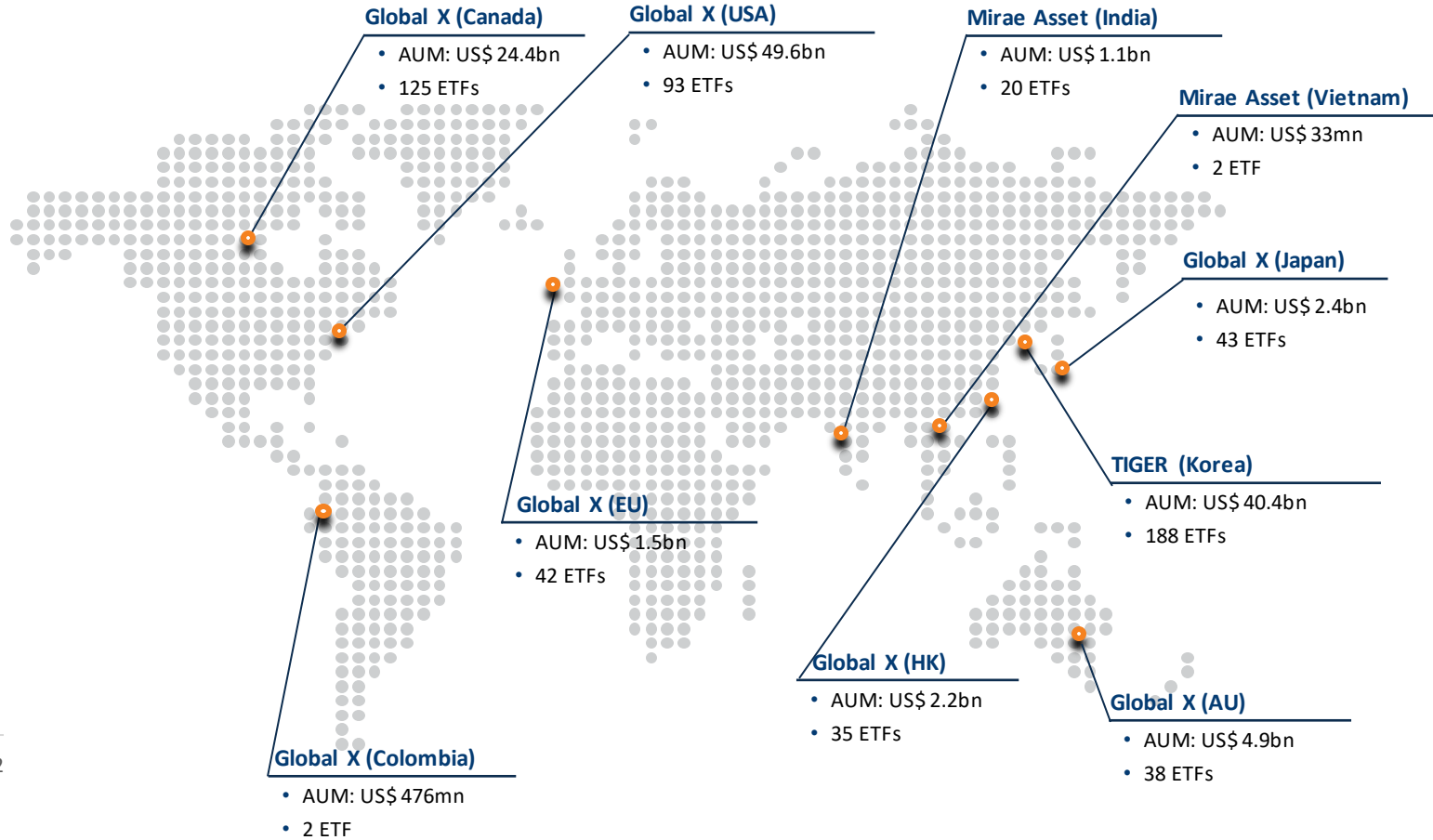
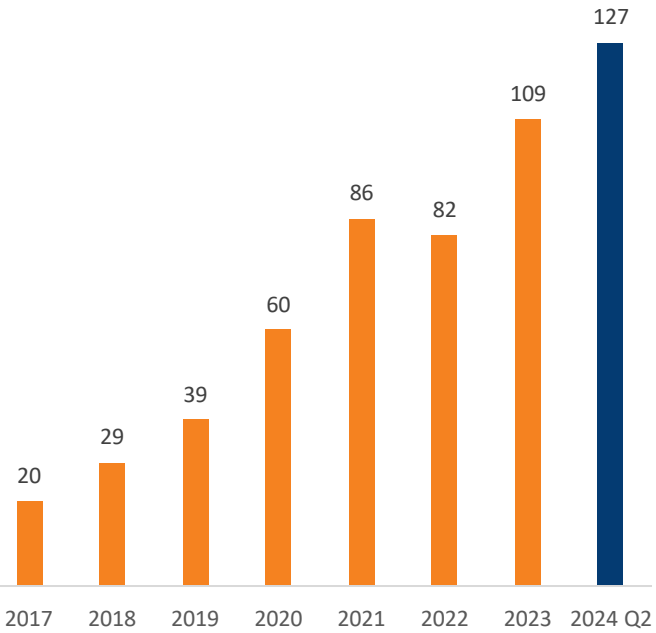
AUM by Client Type

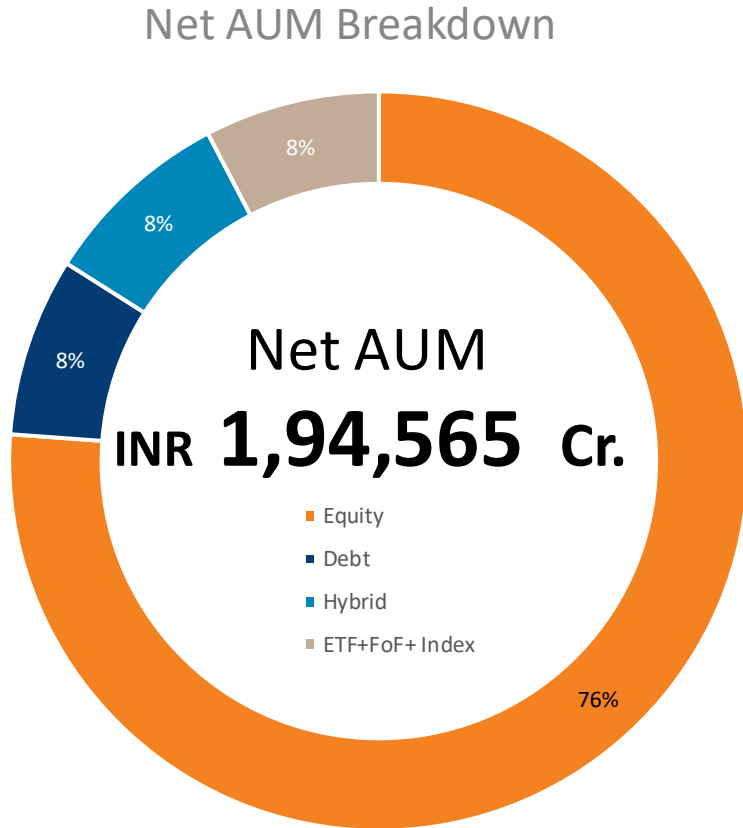

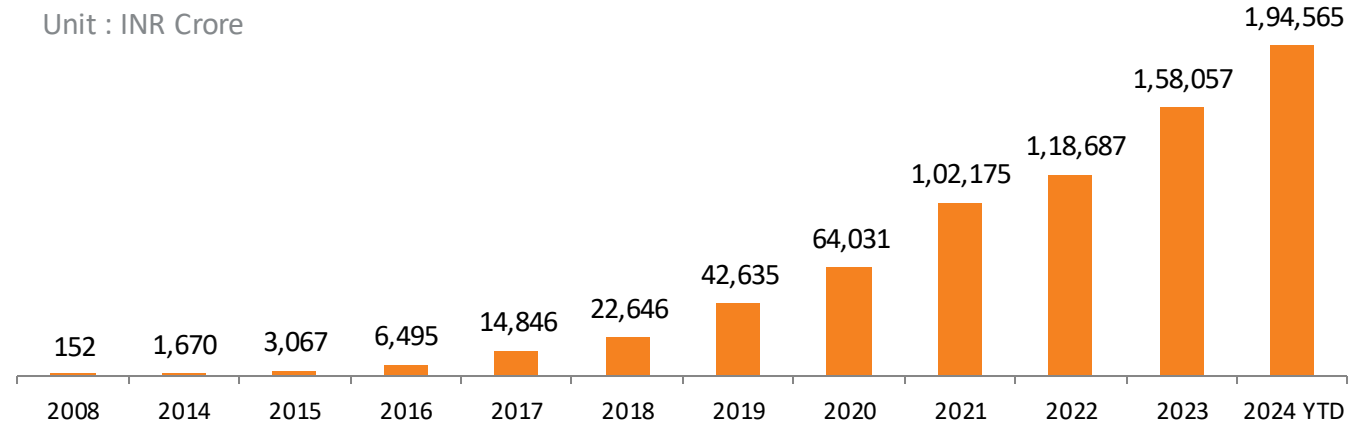

AUM Growth Trend

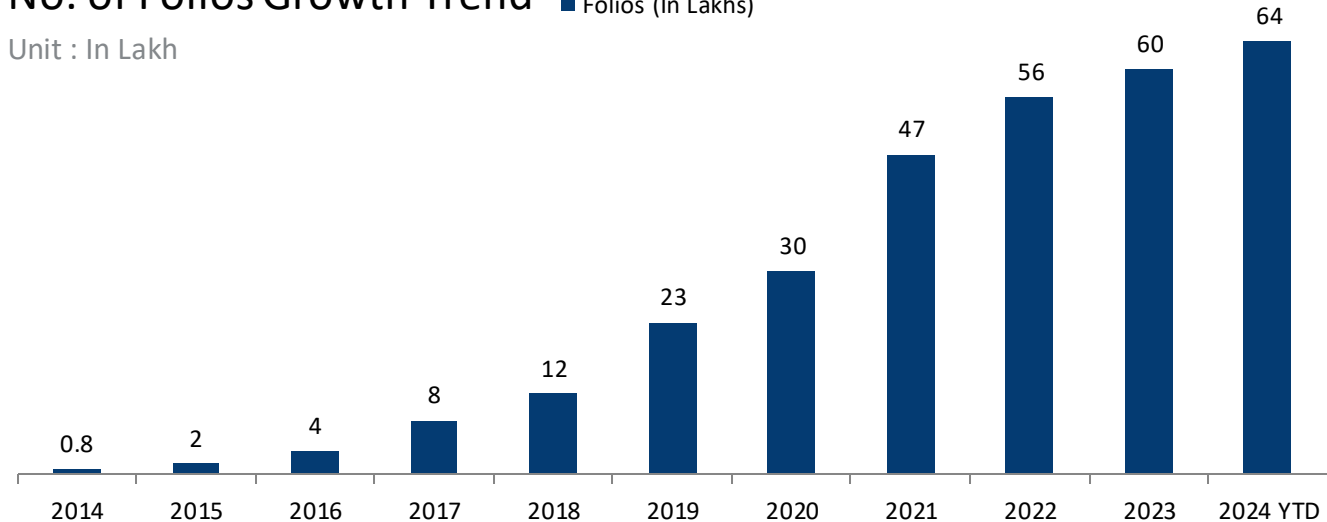

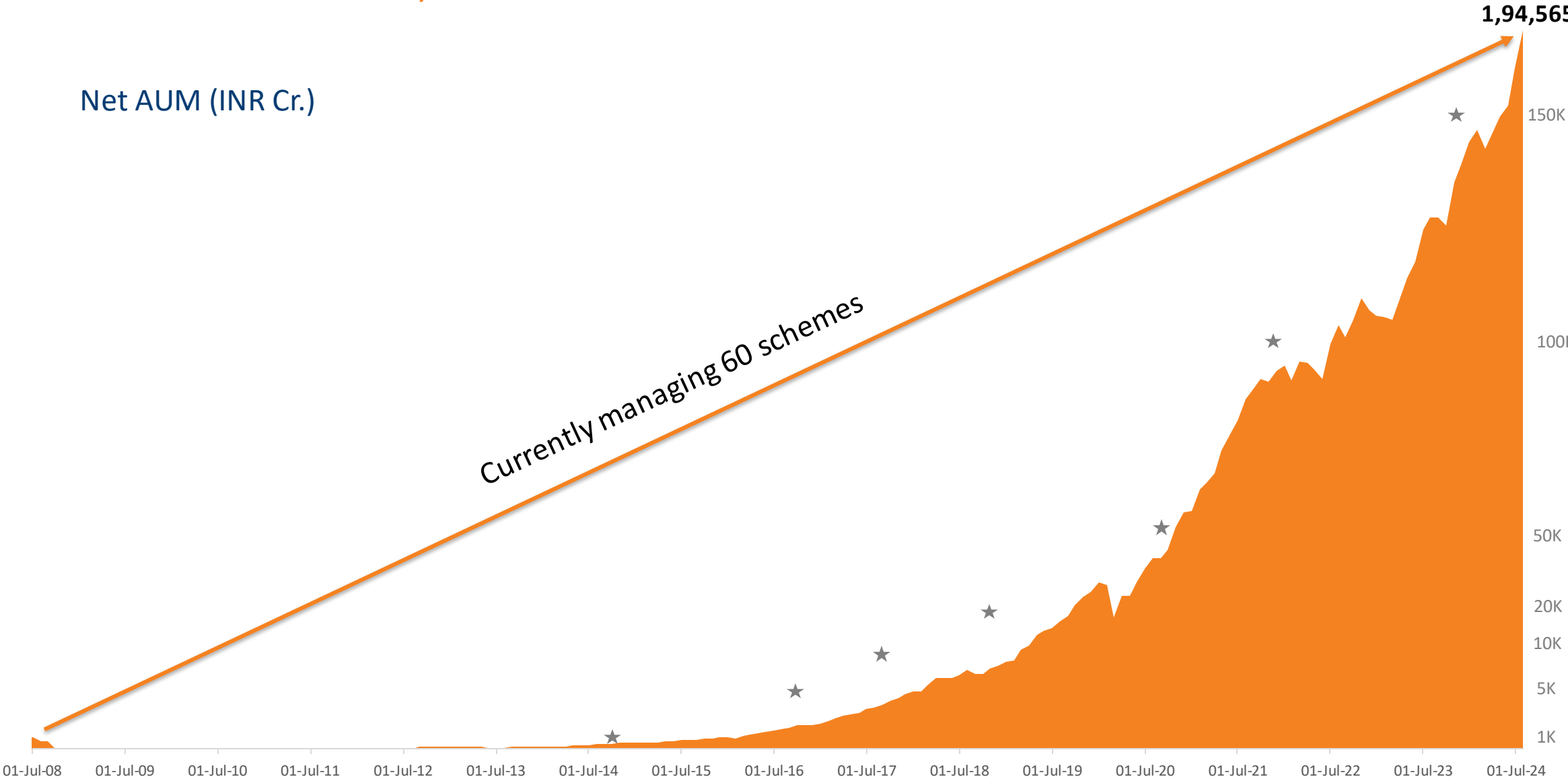
