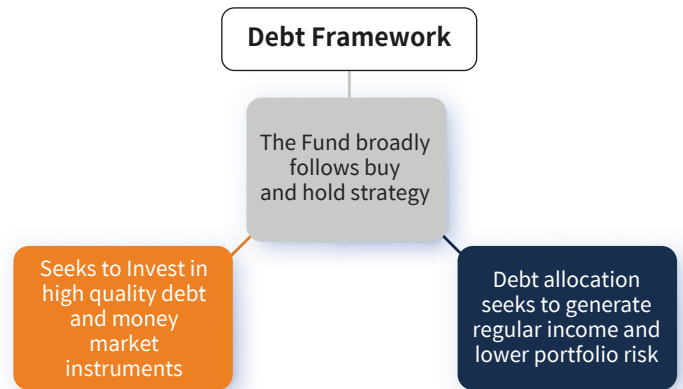
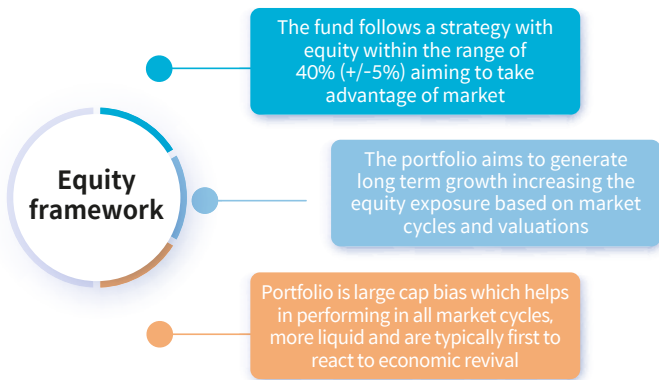

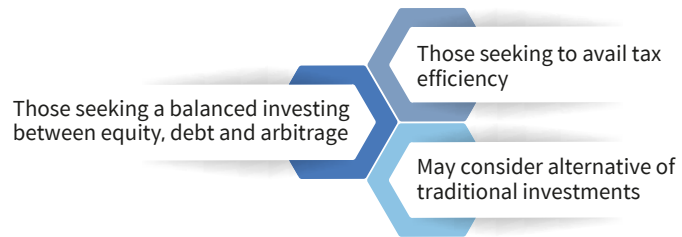
### MAESF Investment Framework<sup>§</sup>

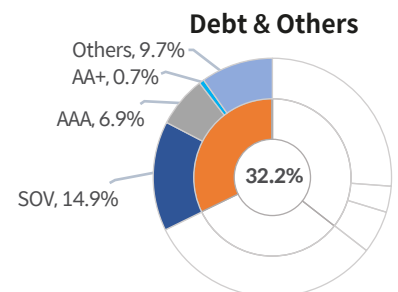
